HUD Posts Materials for HCV Utilization Tools Webinar

On the <u>HCV Program Trainings and Resources</u> webpage, the Department of Housing and Urban Development (<u>HUD</u>) has posted the <u>recording</u> for the "HCV Utilization: Back by Popular Demand - TOOL TIME!" webinar that was held on October 12, 2022. The webinar included an update on funding from the HCV's Financial Management Division. In addition, there was a discussion surrounding some of the misunderstandings in Notice <u>PIH 2022-30</u>; particularly, whether a PHA could apply for the first time. During the live web conference, HUD also discussed how the Two-Year Tool handles CY 2023 on the proration, inflation, and offset fronts. The call wrapped up by working through a specific example of a Payment Standard Tool and a Two-Year Tool.
