HUD Clarifies Use of FHAP Funds for Source of Income Testing Activities

On February 12, 2024, the Department of Housing and Urban Development (<u>HUD</u>) published a <u>memorandum</u> that clarifies that funds provided under HUD's Fair Housing Assistance Program (<u>FHAP</u>) can be used to support source of income testing activities. According to the document, FHAP funds can support source of income testing projects that are designed to uncover discrimination that violates the <u>Fair Housing Act</u> or substantially equivalent state or local fair housing laws.
