### **HUD Posts Materials for Improving Program Data Webinar**

On the <u>HCV Program Trainings and Resources</u> webpage, the Department of Housing and Urban Development (<u>HUD</u>) has posted the <u>recording</u> and <u>presentation slides</u> for the "HCV Utilization: Improving Program Data and 2023 Funding Update" webinar that was held on January 19, 2023. The live web conference focused on the importance of timely and accurate household data (from the form HUD-50058) and how this data informs leasing success rates and help PHAs transition to eVMS. HUD also provided an update on the 2023 Appropriation and the significant HCV funding increase PHAs should expect.

Note that submitting a registration request does not confirm eligibility to attend the course. Participants must meet all eligibility requirements and fully complete the two-step registration to be enrolled in the course.

The NFHTA was launched in July 2019 to prepare fair housing advocates, lawyers, investigators, and other stakeholders on effective strategies and techniques for addressing discriminatory housing policies and practices throughout the nation.
