Public Housing Waiting List Submissions Due March 31

In an email yesterday via HUD's Financial Management Division (FMD) mailing list, HUD's Office of Public and Indian Housing (PIH) advised PHAs that the deadline for the Public Housing Waiting List submissions is March, 31, 2024. The Public Housing Waiting List module provides PHAs the ability to easily report the total number of families on the PHA waiting lists for admission to the public housing projects or units of the agency. The email includes a user guide and a link to a <u>training video</u> to help complete the submissions.

PHA 5-Year and PHA Annual Plan New Software Now Active

In another email sent yesterday via HUD's Financial Management Division (FMD) mailing list, HUD's Office of Public and Indian Housing (PIH) advised PHAs that the PHA 5-Year and PHA Annual Plan new software is now active. According to the announcement, the new software have additional features and enhancements in responding to user demands.

The PHA 5-Year and PHA Annual Plan related test submission data were deleted to accommodate the improved version of the software and PHA users may now resume additional testing. All testing data will be deleted by May 3, 2024.

The modules, which will provide PHAs with the ability to create and submit PHA plans and related certifications, are applicable to all PHAs (Standard, Troubled, High-Performer, Small, Housing Choice Voucher, and Qualified). PHAs will need to complete different variations of the HUD-50075 and certifications.

For guidance on how to complete the PHA 5-year and PHA annual plan, review Notice PIH-2015-18. Additionally, the email includes the PHA 5-Year Plan User Guide and the PHA Annual Plan User Guide.
