HUD Publishes 2022 FUP NOFA

Yesterday on [Grants.gov](#), the Department of Housing and Urban Development ([HUD](#)) [posted](#) the notice of funding availability ([NOFA](#)) for its FY 2022 Family Unification Program ([FUP](#)). The NOFA makes available approximately \$5,000,000 for new voucher assistance to PHAs with demonstrated experience and resources for supportive services, as evidenced by an executed memorandum of understanding with a public child welfare agency. The FUP voucher assistance is intended for the following groups:

- Families for whom the lack of adequate housing is a primary factor in the imminent placement of the family’s child or children in out-of-home care, or the delay in the discharge of the child or children to the family from out-of-home care; and
- Youths at least 18 years and not more than 24 years of age who left foster care or will leave foster care within 90 days and are homeless or are at risk of becoming homeless at age 16 or older.

Application Due Date for Emergency Safety Grants is June 28

HUD’s Office of Capital Improvements ([OCI](#)) has [announced](#) the application deadline date for emergency safety and security funding for fiscal year (FY) 2023. HUD will fund \$10 million in the capital fund grants this year, the same amount that was funded in FY 2022. Applications for the grants, which provide funding for safety and security measures necessary to address crime and drug-related activity or a need for carbon monoxide alarms/detectors, and/or smoke/heat alarms/detectors, are due no later than **June 28, 2023**.

PIH Posts Explanation of May Obligations

HUD’s Office of Public and Indian Housing ([PIH](#)) has [posted](#) a [document](#) explaining public housing operating fund obligations for May 2023. According to the document, May obligations are based on the interim eligibility determined after processing the 2023 operating subsidy forms. All operating subsidy obligations are cumulative, meaning that public housing projects are provided funding in the amount of five twelfths of prorated eligibility.

For PHAs that have not submitted their operating subsidy forms as of April 10, 2023, their eligibility will be an estimated eligibility based upon the data used to prepopulate the operating subsidy forms. This data includes selected elements of final 2022 operating fund eligibility and 2023 HUD-52723 prepopulated data. PHAs are advised that once HUD can utilize HUD-52723 data for eligibility, funding for individual projects may fluctuate significantly.

All operating subsidy obligations are cumulative. As such, to the extent that excess amounts were cumulatively obligated to a project previously, its next obligation (and possibly future obligations depending upon the amount of the overfunding) will reflect a relative decrease. To the extent that insufficient amounts were cumulatively obligated to a project previously, its next obligation will reflect a relative increase.

For the May funding, the Department considered 2023 interim and estimated eligibility to provide a proration level of approximately 92.19%. The proration reflects the difference in the amount of the actual eligibility for final approved HUD-52723 subsidy requests and the available Appropriations. HUD plans to make this round of funding available through eLOCCS no later than May 1, 2023. The next round of funding is expected to be available in eLOCCS no later than June 1, 2023.
