HUD Posts FFY 2024 Shortfall Eligibility Schedule

On the new [2024 Operating Fund Shortfall Funding](#) webpage, the Department of Housing and Urban Development ([HUD](#)) has posted the FY 2024 [shortfall schedule](#). The Department had previously posted the shortfall [notice](#) and the [list](#) of eligible PHAs and the amount they are eligible to receive. The list also shows PHAs that are ineligible to receive shortfall funding and the reason for their ineligibility. The explanation of shortfall obligations, shortfall obligation letters, shortfall funds assignments, and budget due dates are listed as “coming soon.”

As you may know, eligibles PHAs may apply for shortfall funding through the [Public Housing Portal](#) by 5:00 p.m. Eastern time on **June 7, 2024**. If a PHA believes that the information HUD used to determine its eligibility or the financial data schedule (FDS) data itself is inaccurate, the PHA may appeal by **June 7, 2024**.
