PIH Issues Reminder for Timely 50058 Submissions

In an email to PHAs yesterday via HUD’s Financial Management Division (FMD) [mailing list](#), the Office of Public and Indian Housing ([PIH](#)) issued a reminder in preparation for the CY 2024 operating fund grant process for PHAs to submit any actions recorded on lines 2a and 2b of the form HUD-50058 or HUD-50058 MTW no later than 60 calendar days from the effective date. The reminder notes that this requirement is consistent with guidance provided in Notice [PIH 2011-65](#).

As the announcement states, PIH **uses** the forms HUD-50058 and HUD-50058 MTW data reported in the Inventory Management System/Public and Indian Housing Information Center (IMS/PIC) between July 1, 2022, and June 30, 2023, to determine CY 2024 operating fund eligibly. PHAs must update IMS/PIC with correct data including field office approval on allowable vacancies before **August 30, 2023**.

52723/52722 Online Revision Submission Module Now Open

In another [email](#) yesterday via HUD’s Financial Management Division (FMD) [mailing list](#), the Office of Public and Indian Housing ([PIH](#)) announced that the HUD-52723/52722 online revision submission module is now open. PHAs must collaborate with the local field office staff in finalizing their submission by **August 15, 2023**. Requests submitted after this date will not be accepted, unless the change lowers the operating subsidy grant eligibility or results from a documented HUD error, in which case such requests are required. Acceptable reasons for requesting revisions are described in the email.

HUD Publishes Radon Testing and Mitigation Demonstration NOFO

Last Friday on [grants.gov](#), the Department of Housing and Urban Development ([HUD](#)) [posted](#) the notice of funding opportunity ([NOFO](#)) for its Radon Testing and Mitigation Demonstration program for public housing. The NOFO makes approximately \$5,064,179 in grants available to public housing agencies to conduct testing, and when needed, mitigation of radon in the units that they manage. The work supported through this NOFO will also provide HUD with important information on methods and costs for radon testing and mitigation in public housing.
