## PH Portal Now Accepting 5-Year and Annual Plans for PHAs with FYE 3/31

In an email sent this morning via HUD's Financial Management Division (FMD) <u>mailing list</u>, HUD's Office of Public and Indian Housing (<u>PIH</u>) advised PHAs that the Public Housing Portal is accepting PHA 5-Year and PHA Annual Plans for PHAs with fiscal year end (FYE) 3/31. These PHAs must submit their required PHA plans by January 17, 2025.

According to the email, only PHAs with FYEs 9/30, 12/31, and 3/31 may submit their PHA plans in the Public Housing Portal right now. FYE 9/30 PHAs must submit their PHA plans by July 18, 2024, and FYE 12/31 PHAs must submit their PHA plans by October 18, 2024.

The PHA Annual Plan and 5-Year Plan modules provide PHAs with the ability to create and submit PHA plans and related certifications. These modules are applicable to all PHAs (Standard, Troubled, High-Performer, Small, Housing Choice Voucher, and Qualified). PHAs will need to complete different variations of the HUD-50075 and certifications.

For guidance on how to complete the PHA 5-year and PHA Annual Plans, review Notice <u>PIH-2015-18</u>. Additionally, the email includes the <u>PHA 5-Year Plan User Guide</u> and the <u>PHA Annual Plan User Guide</u>.
