HUD Issues Additional Implementation Guidance on CCD

Today in the *Federal Register*, the Department of Housing and Urban Development ([HUD](#)) issued a [notice](#) providing additional implementation guidance on the Community Choice Demonstration ([CCD](#)) for awarded PHAs. Specifically, the notice covers the following topics:

- Additional policies and flexibilities necessary to ensure effective participation
- Changes to selected mobility-related services (SMRS) implementation timeline
- Regional Project-Based Voucher Plan (RPBVP)
- Extension of the demonstration participant enrollment period
- Mobility demonstration vouchers
- Eligible uses of funds
- Demonstration withdrawal and recapture of funds
- Additional allocation and reallocation of funds
- Continued housing mobility-related services after the demonstration ends

The Community Choice Demonstration, previously known as the Housing Choice Voucher Mobility Demonstration, was authorized and funded through the 2019 and 2020 Appropriations Acts. Through the demonstration, HUD will implement, test, and evaluate whether housing mobility programs expand access to opportunity neighborhoods.

HUD to Host Training on PHA 5-Year and PHA Annual Plan Modules

In an email sent this morning via HUD’s Financial Management Division (FMD) [mailing list](#), HUD’s Office of Public and Indian Housing ([PIH](#)) announced that it is hosting a training on the PHA 5-Year and PHA Annual Plans modules for PHAs with FYE 12/31 and 3/31. Note that FYE 12/31 PHAs must submit their PHA plans by October 18, 2024, and FYE 3/31 PHAs must submit their required PHA plans by January 17, 2025.
