## **HUD to Host Trainings on PHA Plans and WASS/ED Security Access**

In an <u>email</u> sent yesterday via HUD's Financial Management Division (FMD) <u>mailing list</u>, HUD's Office of Public and Indian Housing (<u>PIH</u>) announced that it is hosting two more training sessions on the PHA 5-Year and PHA Annual Plans modules. In addition, HUD is offering WASS and Executive Director (ED) Security Access training for PHAs that need assistance assigning user roles for the Public Housing Portal. The dates and times are as follows:

- Monday, September 9, 2024, 1:30 p.m. PHA 5-Year and Annual Plan
- Tuesday, September 10, 2024, 11:30 a.m. WASS/ED Security Access
- Wednesday, September 11, 2024, 1:30 p.m. WASS/ED Security Access
- Wednesday, September 25, 2024, 1:30 p.m. PHA 5-Year and Annual Plan

All sessions are Eastern time. HUD will send the links closer to the training date.

Note that FYE 12/31 PHAs must submit their PHA plans by October 18, 2024, and FYE 3/31 PHAs must submit their required PHA plans by January 17, 2025. For guidance on how to complete the PHA 5-year and PHA Annual Plans, review Notice PHA 2015-18. The email includes the PHA 5-Year Plan User Guide and the PHA Annual Plan User Guide.

## **HUD Announces Latest in UEL Analysis Tool for PHAs Webinar Series**

On the <u>HUD Exchange News</u> webpage, the Department of Housing and Urban Development (<u>HUD</u>) <u>announced</u> that it will host the latest in its series of webinars on the utility expense level (UEL) analysis tool for PHAs. The series is intended for all PHAs that need to document, track, and analyze public housing utility data on an individual project level.

The upcoming webinar, titled "<u>Data Collection and Reporting Requirements</u>," will review the operating subsidy, discuss Form HUD-52722, examine data collection requirements, and go over utility incentives, reporting periods, and utility costs. Additionally, attendees will have the opportunity to participate in a live question and answer session.
