HUD Posts Document on Voluntary Reallocation/Recapture of HUD-VASH Vouchers

On the HUD–Veterans Affairs ([VA](#)) Supportive Housing ([HUD-VASH](#)) Vouchers website, the Department of Housing and Urban Development ([HUD](#)) has posted a [presentation](#) covering the HUD-VASH Voluntary Reallocation or Recapture [notice](#) that was published on August 16, 2022. The document covers the following topics:

- Overview and background of the notice
- Reallocation vs. recapture
- When to consider reallocation or recapture
- Overview of the request and approval process
- PHA request letter requirements
- Processing timeline
- Next steps and questions

As the document states, Notice [PIH 2022-25](#) is intended to increase efficiency and impact of existing HUD-VASH resources by moving vouchers from areas with chronically low utilization to areas with additional need.
